#### *About IIM Rohtak*

Indian Institute of Management Rohtak, established by the Ministry of Education, Government of India is an institute of national importance. Established in 2009, the Indian Institute of Management Rohtak is a benchmark for top management education in India with a vision to become a global leader in due course. The institute has an enlightened and progressive leadership, acclaimed faculty members, extensive infrastructure, and robust teaching pedagogy in place. Located within the National Capital Region (NCR) of India, IIM Rohtak is 90 minutes from Delhi international airport. The state-of-the-art campus spread over an area of 200 acres, is strategically located on National Highway - 10, and is well connected to Delhi. IIM Rohtak has been ranked 8th in the country on educational ranking. Institute offers a dynamic environment for high-quality research in all functional areas of management that will benefit various segments of the business and society.

#### *About IPM Programme*

Five-Year Integrated Programme in Management (IPM) is for students after class XII who aim to pursue their career in Business Management. It is a comprehensive management program that has a combined course of management studies from under-graduate (UG) to postgraduate (PG). Programme aims at molding outstanding young students into managers and leaders. Upon successfully completing academic rigor of 5 years, the participant will be awarded Integrated Programme in Management (BBA+MBA) by IIM Rohtak. The students will have to maintain a minimum CGPA of 5 at the end of third year to be eligible for the last two years of the program to earn a master's degree. Students below 5.0, but not less than 4 CGPA will be awarded a BBA degree and will exit the program. Also, if any student voluntarily intends to exit the program after successfully completing the programme requirement at the end of 3 years, he/she will be awarded a degree of Bachelor of Business Administration (BBA) on notifying the office about the exit within the stipulated time in the third year of the Programme.

Overall, the programme consists of 15 terms spread over a period of 5 years. A year has three terms, each of approximately 3 months duration. The entire programme is divided into two parts; the first part focuses on the foundation courses, whereas the second part focuses on management. Students will be undergoing internships at the end of every academic year.

#### *Curriculum*

The curriculum has four core areas: Mathematics, Economics, Statistics, and Humanities. Apart from these, other courses such as Business Communication, Management Information System, Business, and Foreign Languages are also offered. Courses offered at the PG level (4th and 5th Year) will be the same as the PGP curriculum.

## Admission Criteria:

Candidates must satisfy the following criteria to apply for this programme.

- General, NC-OBC and EWS Category: Minimum 60% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as of June 30, 2024
- SC, ST and PWD (DAP) Category: Minimum 55% in standard X/ SSC and standard XII/ HSC or equivalent examinations, Maximum 20 years of age as of June 30, 2024

**Note 1:** Candidates who are likely to complete standard XII/ HSC or equivalent by the end of June 2024 can also apply, subject to meeting the minimum eligibility criteria after the declaration of results (only in case of XIIth standard) as mentioned above. If selected, such candidates will be offered admission to the programme provisionally. At the time of registration for the programme, such candidates must produce X and XII standard mark sheets (securing minimum marks, i.e. 60% for General, EWS, and NC-OBC or 55% for SC, ST, and PWD) along with school leaving certificate/migration certificate, failing which the candidate's admission offer stands cancelled.

**Note 2:** The percentage of marks obtained by the candidate in X and XII Standard would be calculated based on the aggregate marks of the best five subjects that appear in the mark sheet/grade sheet, irrespective of the Board's regulation. In case the candidates are awarded letter grades or grade points instead of marks, the conversion of grades to the percentage of marks of the best five subjects would be based on the procedure certified by the Board/ Competent Authority explaining the method of conversion from where they have obtained the certificate.

## Selection Procedure:

### Stage I: Online Registration

- Interested applicants who fulfil the above-mentioned eligibility criteria will fill out the registration form that aims at evaluating the applicant's proficiency in academics as well as in extra-curricular activities.
- The eligible applicants will pay a non-refundable registration fee of Rs. 4500/- (Four thousand five hundred Only)

### Stage II: IPM Aptitude Test (IPM AT 2024)

- All the interested applicants will undergo IIM Rohtak's IPM Aptitude Test that will examine the aptitude, logical reasoning, and proficiency in English of the applicant.
- IPM AT 2024 to be conducted on May 18, 2024 from 9:00 AM onwards.**
- IPM Aptitude Test will comprise of following sections:

Section	Number of Questions	Time Duration for each section
Quantitative Ability	40	40 minutes
Logical Reasoning	40	40 minutes
Verbal Ability	40	40 minutes

**Note:** Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

- In case the candidate also selects the Integrated Programme in Law (IPL) option while registering for IPM AT 2024, such candidates will also appear for the fourth section as

following:

Legal Reasoning	20	20 minutes

Note: Each question will carry 4 marks. There will be a negative marking of 1 mark for each wrong answer. All the questions will be multiple-choice questions.

### **Stage III: Shortlisting and Personal Interview (PI)**

- (i) The shortlisted applicants will be called for a Personal Interview on the basis of minimum eligibility criteria and IPM AT Score 2024.
- (ii) The announcement of Call for Personal Interviews (PI) will be done in the First Week of June 2024 (Tentative).
- (iii) The candidates during their personal interviews will be judged on the basis of their academics, general awareness, and communication skills.
- (iv) The interviews are proposed to be held in the Second Week of June 2024 (Tentative)

### **Stage IV: Announcement of Selection List**

- (i) The Final Merit List will be generated based on the composite score of IPM AT 2024, Past Academics, and Personal Interview.
- (ii) The institute will tentatively announce the merit list by the first week of July 2024. The offer of admission to the candidate will be made strictly on the basis of merit/ rank list and availability of seats in each category (General, EWS, NC-OBC, SC, ST & DAP) as per reservation rules of Govt. of India.

### **Stage V: Provisional Admission to IPM Batch VI (session 2024-29)**

- (i) All selected candidates will receive a provisional offer letter for admission from [ipmadmission@iimrohtak.ac.in](mailto:ipmadmission@iimrohtak.ac.in) on their registered email ID shortly after the merit list declaration. A candidate receiving an admission offer from IIM Rohtak (IIM-R) and accepting the offer within the stipulated date needs to deposit Rs. 1,00,000/- as the OAA i.e. Offer Acceptance Amount (or as mentioned in the Offer Letter) through the institute's admission portal only. An automated receipt and a text message of the transaction will be shared by the associated bank on the registered email ID/ mobile no. of the candidate.
- (ii) On acceptance of the admission offer and payment of OAA, the candidate will receive his/her confirmation letter for provisional admission to IPM Batch VI (Session 2024-29) on his/her registered email ID. The paid OAA will be adjusted with the First Year Programme Fee. Such candidates will be required to pay the 1st instalment of the First Year Programme Fee (as mentioned in the confirmation letter) through the institute's admission portal only. If a candidate fails to pay the 1st instalment of First Year Programme Fees by the stipulated date mentioned in the admission confirmation letter, the seat will be cancelled.
- (iii) The fee structure for IPM Batch VI (Session 2024-29) is available on the institute's website.

### **Stage V: Reporting for joining the IPM Batch VI (Session 2024-29)**

- (i) Final selected candidates who have deposited OAA and got a confirmation letter for provisional admission will be required to report physically (on the stipulated date and time) on the Institute campus for registration, followed by physical verification of educational documents and other testimonials as per checklist (in case of online registration, the documents will be verified virtually).
- (ii) The academic session will tentatively begin in the first week of August 2024.

- (iii) The hostel room allocation to the candidate will be done on a sharing basis. Hostel rooms for the DAP category candidates will be arranged on the ground floor.

**Note:**

- (i) The admission criteria for IPM Batch VI (Session 2024-29) may be changed before the declaration of the results.
- (ii) The information in this document is applicable only for the admissions cycle IPM Batch VI (Session 2024-29). IIM Rohtak reserves the right to change, modify or adopt any new admission process that it deems necessary at any point.
- (iii) Any dispute concerning Admission for the IPM Batch VI (Session 2024-29) would be subject to the jurisdiction of the competent courts within the territorial jurisdiction of the city of Rohtak only.
- (iv) You will receive all admission offers in the form of a letter duly signed by the Controller of Examinations of IIM Rohtak sent from [ipmadmission@iimrohtak.ac.in](mailto:ipmadmission@iimrohtak.ac.in). Any offer received from any other email is completely invalid and is not official. All admissions to IIM Rohtak are provisional till you have completed all formalities upon reporting to the institute.
- (v) If at any point of time it is found that the information provided by the candidate is false, incorrect, or misrepresented, the admission offer will stand cancelled.
- (vi) IIM Rohtak reserves the right to change, modify or adopt any new admissions process that it deems necessary at any point.

**Refund Policy for IPM Batch VI (Session 2024-29)**

The last Date for any withdrawal of provisional admission will be ‘On or before the date of Registration’ (online/ on campus, as the case may be). The entire fees received from the student, after deduction of the processing fee of Rs. 1000/- (one thousand only), will be refunded to the candidate by the mode of bank transfer to the candidate’s own savings bank account provided by the candidate. The refund requests will be accepted only through the institute’s admission portal, i.e. <https://admission.iimrohtak.ac.in/SignIn/ipm-2024-29>

Refunds will be made automatically within 150-180 days from the date of registration of the program. Please provide your own (i.e. candidate’s) correct banking details (Beneficiary Name, Saving Bank Account Number, Bank Name, IFSC code) through the institute’s admission portal, i.e. <https://admission.iimrohtak.ac.in/SignIn/ipm-2024-29>

**Total no. of seats:**

Total no. of seats for IPM Batch VI (Session 2024-29) will be 165 (including 10% of the total seats will be offered to EWS (Economically Weaker Section) candidates). The offer of admission to the candidate will be made strictly based on merit/rank list and availability of seats in each category (Gen, SC, ST, NC-OBC, EWS & DAP) as per reservation rules of Govt. of India.

**Hostel Allocation:**

IIM Rohtak offers full-time residential IPM programme. Therefore, the institute provides hostel rooms to the students on a sharing basis with the following facilities:
